Over the course of his career, Mark has spoken at multiple conferences on white collar criminal defense and tax litigation topics. He has been selected by his peers as one of Pennsylvania's Super Lawyers for White Collar Criminal Defense and has served as an executive member of The Temple American Inn of Court. He is a member of the American Bar Association, Criminal Justice Section and Tax Section. In 2018, Mark was invited to become a Fellow of The American College of Trial Lawyers, recognized as the preeminent organization of trial lawyers in North America.

In addition to his work for private clients, Mark represents indigent defendants in federal criminal matters. Specifically, he is both a member of the Criminal Justice Act (CJA) Panel for the United States District Court for the Eastern District of Pennsylvania (EDPA) and the EDPA's CJA Panel Representative. In his role as the court's representative, he collaborates directly with all stakeholders to resolve issues affecting the panel as efficiently as possible.
